Registration fees and forms are required to reserve your space at CDO. Registrations will be taken in the order they are received. Class sizes are limited. Knox CDO reserves the right to change class assignments based on enrollment.

## Set Schedule Option

This is a set schedule with monthly tuition payments. Your child will attend on the same day (or days) for the school year. No need to “sign up” for attendance days. A limited number of spots available in each class. Class confirmation will be sent by email. All classes are 9:00 a.m-1:00pm
